Conservation organization files suit against resources commission

On March 28, the nation's largest statewide conservation organization [filed suit against the Natural Resources Commission](#) (NRC), challenging the three-month closure of the coyote hunting season.

At the March NRC, the commission, in a 4-2 vote, voted to close the coyote hunting season from April 16 through July 14 through the adoption of Wildlife Conservation Order #1 of 2024. Michigan United Conservation Clubs (MUCC) testified in opposition to the closure.

MUCC filed in Ingham County, arguing that the commission unlawfully closed Michigan's coyote season, violating their responsibility and legal charge. The Michigan Trappers and Predator Callers (MTPCA) has also filed a lawsuit against the commission in Mackinac County.

The groups argue that the NRC relied on unsubstantiated claims of negative public perception and perceived potential loss of management control, said MUCC Chief Executive Officer Amy Trotter.

"The record is unambiguous: the commission has not heard or cited any scientific literature or rationale justifying the closure," Trotter said. "Meanwhile, there were hours of public testimony on the practical benefits of coyote hunting during the spring season, while being reinforced with cited literature."

MUCC's mission is to unite citizens to conserve, protect, and enhance Michigan's outdoor heritage, and this issue is bigger than coyote hunting, said MUCC President Rob Miller.

"The board voted unanimously to take this action, consistent with MUCC's mission," Miller said. "MUCC was founded on the belief that game management decisions should be grounded in science and insulated from political and social pressures. This is a foundational issue for our organization, and we were obligated to act on behalf of Michigan's conservationists."

Mark Spencer, president of the MTPCA, said the idea that trappers and predator callers are behind the closure is misguided.

"The stance taken with litigation clearly shows the trappers and predator callers of Michigan are firmly united behind the principles of science-based management," Spencer said. "Our groups present a united front to ensure our outdoor heritage is protected and grounded in science for generations to come."

MUCC's notice, filed in Ingham County Circuit Court, will be followed by the organization's briefs. The process is expected to play out over the coming months and MUCC can not waver on its principles, said Trotter.

"MUCC is the nation's largest, most successful, statewide conservation organization," said Trotter. "We were founded for moments like this, and we will continue our work to conserve, protect, and enhance Michigan's natural resources and outdoor heritage."

MUCC Supported Commercial Fishing Legislation introduced in Mi. House

On March 6, Rep. Amos O'Neal (D-Saginaw) introduced a stakeholder-backed modernization of Michigan's commercial fishing statute.

[House Bill 5553](#), written over the past several months in partnership with MUCC, would modernize archaic regulations in the state's commercial fishing statute, and keep gamefish out of commercial nets.

Michigan's commercial fishing statute is decades old and an update is long overdue to protect the pristine Great Lakes fishery, said Amos O'Neal.

"Michigan is so beautiful with its lakes and streams, and one of my favorite pastimes in the summer is to fish," said Rep. O'Neal. "I am proud to introduce a bill to modernize the state's commercial fishing industry. House Bill 5553 makes a change to commercial fishing that has not taken place in over 50 years. These protections are long past due."

According to MUCC Policy and Government Affairs Manager Justin Tomei, the current commercial fishing statute needs to be revised protecting the investment licensed anglers have made in the management of our sportfish. "Currently we operate with an abhorrent patchwork of rules and regulations, many of them have not been updated since the 1970s," said Tomei. "We must modernize this industry, create a single regulatory framework in statute, and keep gamefish out of commercial nets, protecting the investment licensed anglers have made managing and rearing these fish."

The bill has been assigned to the House Committee on Natural Resources, Environment, Tourism, and Outdoor Recreation.

HB 5553 starkly contrasts HB 5108, introduced by Rep. Jason Morgan (D-Ann Arbor) last fall. HB 5108 sets minimum quotas for gamefish to be caught by state-licensed commercial anglers, commercializing a resource held in the public trust.

MUCC opposes HB 5108 and started a call to action resulting in 85,000 emails being sent to legislative offices in opposition to the commercialization of Michigan's game fish.

MUCC supports HB 5553 and looks forward to working with legislators to secure passage in 2024.

March NRC: Commission Votes to End Year-round

Coyote Hunting

Commissioners voted to close Michigan’s coyote season from April 15 to July 15 at March’s Natural Resources Commission (NRC) meeting.

Commissioners voted on [Wildlife Conservation Order #1 of 2024](#), and based their decision on perceived social pressures, shirking their responsibility and legal charge to follow sound scientific management.

MUCC Chief Executive Officer Amy Trotter said that this sets future managers at a disadvantage, making it harder to use lethal control.

“No scientific evidence has been presented to justify the closure of the coyote hunting season, and the NRC had an obligation to oppose this part of the order per Proposal G and the authority it provides to them,” Trotter said. “Now enacted, it will make the fight to defend lethal wildlife management that much harder.”

MUCC Policy and Government Affairs Manager Justin Tomei said the science on coyote management is clear.

“Today, we laid out a clear scientific argument for the use of lethal coyote management, via hunters, during the spring and summer months,” said Tomei. “Coyote management is most effective in the spring when you can actively control local predator populations, limit depredation and increase deer densities.”

MUCC also made the case that the commission should at least wait until the conclusion of the Deer Management Initiative (DMI) to see what recommendations the workgroup comes up with regarding predator management.

“The first question during the first DMI meeting was about predator management,” Trotter said. “The DMI will inevitably make some recommendation regarding predator management, and the commission should wait to ensure all stakeholder opinions are considered.”

The vote came after commissioners rejected attempts from commissioners Nyberg and Walters to remove the closure from the wildlife conservation order and table the vote. Ultimately the closure was adopted on a 4-2 vote, closing coyote season beginning April 15.

MUCC opposed the closure based on a 2005 and 2024 policy supporting year-round coyote hunting. For many years, MUCC has advocated on behalf of its grassroots members to expand opportunities to harvest coyotes.

At [MUCC's Annual Convention](#) this past weekend, its membership unanimously adopted another resolution reinforcing our unwavering commitment to sound scientific management and year-round coyote hunting.

Before the committee of the whole, the wildlife committee saw a presentation on deer predation in the UP, and the fisheries committee saw a presentation on invasive carp.

The director's report featured a 40 years of service award, the wildlife division annual report, migratory game bird hunting seasons overview, elk regulations, and a Deer Management Initiative update.

The commission had two orders up for information at the meeting.

[Wildlife Conservation Order #2 of 2024](#) sets season dates, within federal guidelines, for migratory waterfowl species. The season dates and bag limits fall in line with the 2023 season structure

[Wildlife Conservation Order #3 of 2024](#) sets elk regulations, to which there are no substantive changes to dates, regulations, or quotas. The order includes a return of in-person check stations, something constituents have asked for as a community event.

Both of these orders are eligible for action at the April 11 meeting.

MUCC reviews all land transactions exceeding 80 acres, of which there was one. [Land Transaction Case #20240002](#) is a gift of 200 acres, which will be dedicated as part of the Barry State Game Area.

How to become a Michigan Recreational Safety Instructor

Background and Problem

Over the last several years, the Michigan Department of Natural Resources (DNR) has been developing a new process to become a certified Michigan Recreational Safety Instructor. This process was rolled out at the beginning of 2024 and is only necessary for **new** instructors for all programs (Bow Hunter Education, Trapper Education, Snowmobile Safety, ORV Safety, Boating Safety and Hunter Education). Some of these courses are required by law, and others are highly encouraged to conduct these activities safely. To find out if you need to take one of these courses and which ones, [click here](#).

While instructors have always been expected to meet a level of professionalism and safety, the instructor certification process for all six programs has been inconsistent and has not always prepared instructors to teach these programs effectively. There are also current instructors who are **inactive** in their volunteer roles, making it more difficult for students to find courses. However, there will always be a need for new Recreational Safety Instructors and MUCC wants to disseminate this information widely so the supply of classes will be able to keep up with demand.

New Recreational Safety Instructor Application and Training Process

Taking the time to go through the new process is crucial to ensure we have safe and active individuals in the woods and on our waters.

First, you must be qualified to become an instructor. Qualifications include being 18 years of age or older, having a high school diploma or GED, having no felonies or convictions and having a student safety certificate for the course you are applying to teach. For a FULL LIST of qualifications, head to <https://www.michigan.gov/dnr/about/get-involved/volunteer-recreational-safety-instructor>.

Next, you will apply online by completing the instructor application found [HERE](#). Once the DNR receives your application and you meet all the qualifications, they will conduct a background check. You will be notified via email of your background check results. If you pass, you'll receive the next steps in the application process in that email. If you do not pass the background check, you will not be allowed to proceed in the process and your application will be withdrawn.

Three virtual modules must be completed within six months of getting your background check results. Module 1 must be completed before receiving Module 2, and the same for Module 3. Once you complete these three modules, you can attend one of the **mandatory** two-day, in-person trainings. To ensure a fair process for every interested party, there is a paper application process for those with a valid reason for not using a computer, phone or tablet to complete the online process.

After completing the three virtual training modules, you will be approved to attend the two-day, in-person training. Right now, these in-person trainings will be held at the Ralph A. MacMullan (RAM) Conference Center in Roscommon, MI. The DNR has released three dates for this training, with one TBA for January 2025. You must attend ONE of the following training dates:



April 20-21, 2024

July 19-20, 2024

October 19-20, 2024

The two-day training is free of cost, and meals and housing are provided to all participants. You will be notified via email after completing the three virtual training modules on how to register for the in-person training and additional information. Once you meet all the training requirements, including passing a final exam, you will officially be a certified Michigan Recreational Safety Instructor for the program in which you were trained.

Current Instructors

If you already are a Recreational Safety Instructor, thank you. Michigan needs you. The DNR, as well as organizations like us at Michigan United Conservation Clubs, value the time you put into leading classes. Current instructors do NOT have to participate in any of the required training, including attending any of the two-day in-person trainings mentioned above.

What you do have to do is fill out the survey that was sent to your email on February 1, 2024. Once you review the new policy and procedure manual, click the link in that email and complete the survey. This will take you less than 30 seconds. You MUST complete that survey BEFORE May 1, 2024, and cannot instruct any classes until doing so, no matter what program you teach.

Current Hunter, Bow, and Trapper instructors must attend a hunter education workshop within two years of their initial certification and attend one every two years after that. This helps ensure instructors teach the most up-to-date information and are following proper policies and procedures. Instructors will receive an email with the finalized schedule and can find it posted in Event Manager.

In Michigan, there are constant changes in regulations for hunting, trapping, boating and all recreational activities. It is not only the participants' responsibility to stay up to date on these changes but also a requirement for volunteer Recreational Safety Instructors.

Michigan needs more instructors, but we do not need to cut corners to up our numbers. We are not teaching people and our youth how to make a paper airplane or ride a bike. We are teaching them how to handle firearms, how to survive in the woods if they get hurt or lost and how to be safe and ethical conservation enthusiasts. Teaching these things should not be taken lightly, and all should be willing to do what is required to become a certified Recreational Safety Instructor.

#3. President with boards approval, can appoint an additional 2 more Directors at Large with a total of 4 appointed at large directors on the executive board **Passed as amended.**

#4. Replace the term “Executive Director” with “Chief Executive Officer” at every occurrence in the bylaws. **Passed**

At this time, each affiliated club receives a particular number of votes at the Annual Michigan United Conservation Clubs Convention (MUCC) based on the size of their club roster. 8-10 oz. of Filet per person
1/2 cup of white wine
1 Garlic clove, chopped fine
1 oz. Brandy
2 eggs beaten well
Olive oil to sauté

1 Teaspoon Butter
Juice of one lime
Basil to taste
Fresh vegetable your choice
Flour to dredge

Coat filets with flour, place in beaten eggs. Pour olive oil in hot pan. Then place filets skin side up in pan. Brown both sides and simmer 1 minute with brandy (optional). Add butter, white wine, lime juice, basil and garlic. Simmer for 1 minute, add vegetables, cover and simmer for 2-3 minutes. Uncover and reduce volume over high heat until thick and creamy.
